ITEM #1 Discussion Items

- Discussion & Proposed Revision/Clarification to Committee By-Laws or the SOG 804:
 - SOG 804 Revisions/Updates:
 - (1) The Committee began a conversation re: the standards for qualification of trainee and qualified positions and possible revised standards for the next version of the SOG 804.
 - (2) Other than transfer files, the State Qualification Committee does not accept requests for Faller 2 or Single Recourse Boss (trainee or qualified) without District Committee approval.
 - <u>Committee By-Laws Revision:</u> The committee meetings are currently set for January, April, July, and October. During the meeting Shelby proposed that we set the actual date for the meeting as the 4th Wednesday. The committee approved the idea. The State Qualification Committee Meetings will now be scheduled for the 4th Wednesday of January, April, July, and October. The deadline to submit for each committee meetings will be the 1st Wednesday.
 - <u>Committee Membership:</u> (1) Jeff Gallivan will finish updating the DFFM Chainsaw policy when NWCG completes their planned revisions and will continue as the Committee Chainsaw Representative. When the person completes the CIM requirements, the committee will review.
