#### **ITEM #1 Discussion Items**

#### • <u>Discussion & Proposed Revision/Clarification to Committee By-Laws or the SOG 804:</u>

- SOG 804 Revisions/Updates:
  - (1) The Committee began a conversation re: the standards for REMS Teams Certifications. We discussed making use of NFPA 2500 as the standard for the Rope Rescue requirements that are listed in the REMS Training and Qualifications standards (Attached).
  - (2) Other than transfer files, the State Qualification Committee does not accept requests for Faller 2 or Single Recourse Boss (trainee or qualified) without District Committee approval.
  - (3) The committee members requested standardized guidance re: transition of Non-Federal records.
- <u>Committee By-Laws Revision:</u> (1) The new State Committee by-laws will include a requirement that all meetings have a live and remote option. In addition, each committee member must attend at least two live meetings each year. If unable to attend 2 meetings during the year the person's will be replaced the following year. (2) By-Laws for the District Committee are being developed as well. Input was requested and noted; please update as appropriate.
- <u>Committee Membership:</u> (1) The NWCG chainsaw policy is available on the NWCG website. Jeff Gallivan will finish the DFFM Chainsaw Policy to work in tandem with the NWCG policy. (2) There is a vacancy on the State Committee in the A1S (Northern) District. Please email Rick Miller if you are interested in becoming a Committee member to represent the A1S District. If anyone needs information to fill a State Committee slot please contact Susan Burger.
- **IMT to CIMT Transition:** DFFM is following the NWCG and SWCG guidelines for the transition into the CIMT qualifications. Committee review is not required for technical updates. Committee review will continue for approving new positions. For example, no committee review is required for a person to switch from a current Type 2 trainee to a CIM trainee. When the person completes the CIM requirements, the committee will review.
- **SOFF:** Per NWCG Transition Plan for the new SOFF position, the Committee approved the SOFF position to be granted to Each current SOFR, SOF2, SOF1, SOFC who meets the Arduous Fitness standard. ### **REMS Team Responsibilities and Procedures**

The major responsibilities of the REMS team are stated below:

- Check in and obtain briefing from the Logistics Section Chief or the MEDL, if established. The briefing should provide the following:
- Current incident situation
- Review the Medical Plan (ICS 206) and "Incident within an Incident" Plan
- Incident communications channels
- Anticipate needs and ensure equipment needs as necessary:
  - Incident base assignments
  - o Fireline assignments
  - Spike camp assignments
  - o Resupply expended materials when necessary
- Secure operations and demobilize as outlined in the Demobilization Checkout (ICS 221)
- Maintain a Unit/Activity Log (ICS 214)
