<ul style="list-style-type: none"> • <u>Discussion & Proposed Revision/Clarification to Committee By-Laws or the SOG 804:</u> • <u>SOG 804 Discussed Revisions:</u> (1) The Committee created a sub-committee to identify and establish specific training and experience requirements for the REMS Team (EMTF and EMPF) during the last meeting. The southern area members submitted some input that will be forwarded to the Northern area members by the end of January. This discussion will continue during the next scheduled committee meeting in April. (2) Alternatives to the criteria for initiating task books in the Planning, Logistics, and Finance sections were considered. Accepted revisions will be included in the upcoming updates to the SOG-804. (3) The committee looked, again, at the idea of requiring additional training. The members discussed some pros and cons of requiring the "Other Training Which Supports Development of Knowledge and Skills" in the 310-1. After some discussion, the committee decided against adding more training requirements across the board. • <u>Committee By-Laws Revision:</u> There were no revisions or discussions regarding the committee by-laws during this meeting. • <u>Committee Membership:</u> There is a vacancy for Committee membership in the Central District.
