## **ITEM #1 Discussion Items**

- <u>Discussion & Proposed Revision/Clarification to Committee By-Laws or the SOG 804:</u>
  - <u>SOG 804 Revisions/Updates:</u> (1) The Committee did not review the revisions to the SOG 804 during this meeting. The revisions will be reviewed during the April Committee Meeting. The revisions to be reviewed will include (i) incorporating the NWCG Standards for Wildland Fire Chainsaw Operations, (ii) clarification about transferring employees from Outside Agencies and Contractor Companies, (iii) specific direction about authorizing interim approvals, (iv) incorporating 310-1 updates and (v) correction of typos and oversights in the current version. (2) The State Qualification Committee will no longer accept requests for Faller 2 or Single Recourse Boss (trainee or qualified) without the local District Committee approval.
  - Committee By-Laws Revision: There were no revisions or discussions regarding the committee by-laws during this meeting.
  - <u>Committee Membership:</u> Mike Hoye is retiring from Green Valley FD and will no longer be serving on the A3S District or State Committee.. Harley Harmon will continue on the State Committee until further notice.
  - <u>IMT to CIMT Transition:</u> DFFM is following the NWCG and SWCG guidelines for the transition into the CIMT qualifications. Committee review will not be utilized for technical updates. Committee review will continue for approving new positions. For example, no committee review is required for a person to switch from a current Type 2 trainee to a CIM trainee. When the person completes the CIM requirements the committee will review.
  - STATE FMO Approvals: Director Thomas Torres approved as AADM
  - Priority Training Program: Will be sent out mid-March

<u>The Committee Recommends completing S-219 and S-260 Courses for the Single Resource Boss/ICT4 Level firefighters.</u> The "Other Training Which Supports Development of Knowledge and Skills" for each position, as outlined in the 310-1, is recommended for the development of knowledge and skills.
