- **Discussion & Proposed Revision/Clarification to Committee By-Laws or the SOG 804:**
 - SOG 804 Revisions/Updates: (1) The Committee did not review the revisions to the SOG 804 during this meeting. The revisions will be reviewed during the August Committee Meeting. The revisions to be reviewed will include (i) incorporating the NWCG Standards for Wildland Fire Chainsaw Operations, (ii) clarification about transferring employees from Outside Agencies and Contractor Companies, (iii) specific direction about authorizing interim approvals, (iv) incorporating 310-1 updates and (v) correction of typos and oversights in the current version. (2) The State Qualification Committee will no longer accept requests for Faller 2 or Single Recourse Boss (trainee or qualified) without the local District Committee approval.
 - Committee By-Laws Revision: There were no revisions or discussions regarding the committee by-laws during this meeting. Committee Membership: Jim Bell from Corona de Tucson FD has accepted the A3S State Committee position. Welcome Jim

and thank you! Harley Harmon will continue on the State Committee until further notice.
