PLAN SUBMISSION AND PERMIT ISSUANCE FEES

Plan Submittal Fee	\$225
Administrative Fee for Each Permit	\$35
Permit Renewal in which the Permit has not Expired/Cancelled/Finalized	\$35
Resubmittal Resulting from a Correction Notice or Letter	\$100
Addendum – Owner Initiated Change after Permit Issued	\$100

OPERATING WITHOUT A PERMIT RESULTS IN A FEE THAT IS THE 300% OF THE REQUIRED PERMIT FEE

EXPIRED PERMITS

ON WORK, SUSPENDED, ABANDONED FOR 180 DAYS WITH:

- No Changes to Original Approved Construction Plans - Fee ½ the Amount Required for New Permit for Such Work
- With Changes to Original and Approved Construction Plans - Fee is Amount Required for New Permit for Such Work
- On Work Suspended/Abandoned More than 1 Year - Resubmittal is required

PLAN REVIEW FEES

GENERAL CONSTRUCTION PERMIT:

Less than 10,000 sqft (permit still required)	NONE
10,000-50,000 sqft	\$150
Each additional 50,000 sqft/fraction thereof	\$300

EXTINGUISHING SYSTEMS (CLEAN AGENTS, HALON, DRY CHEMICALS AND CARBON DIOXIDE AND OTHERS) - INSTALLATION/MODIFICATION

1-5,000 sqft	\$200
Each Additional 5,000 sqft or portion thereof	\$50

HOOD EXTINGUISHING SYSTEMS – AUTOMATIC

Hood Systems - Single System	\$150
Each Additional	\$150
Automatic Hood Systems – Per Each System Modification	\$75

New/Additional – Less than 1,000 sqft.	\$225

21+ Devices – New Installation Fee of 1-1,000 sqft (see above)	\$225
Additionally, if panel is moved at all, it will be treated as a new installation fee of 1-1,000 sqft (see above)	

FIRE LINE-UNDERGROUND AND HYDRANTS (NEW INSTALLATION OR MODIFICATION)

New - Up to 500 Lineal Feet	\$300
Each Additional or Portion of 500 Feet	\$175

FIRE PUMPS

New Installation – Single Pump	\$250
Each Additional Pump	\$150
Fire Pump Modification – Per Pump	\$100

FIRE SPRINKLER SYSTEMS

Automatic Sprinkler Systems – New/Additional Less than 10,000 sqft	\$375
New/Additional 10,000-50,000 sqft	\$450
Each New/Additional 50,000 sqft/fraction thereof	\$450
Each Story Above/Below	\$200

AUTOMATIC SPRINKLER MODIFICATION

1-20 Heads	\$75
21-50 Heads	\$100

51-100 Heads	\$250

Each Additional 100 Heads	\$100

Inspection Fees will be Assessed on an Hourly Basis	\$164/hour
Minimum 1-hour charge per reinspection	

FAILING TO CANCEL A RESINSPECTION OR NOT BEING PREPARED FOR A SCHEDULED INSPECTION WILL RESULT IN A MINIMUM RESINSPECTION CHARGE, WHICH INCLUDES ROUNDTRIP TRAVEL TIME TO THE SITE.
